## PRODUCT DESCRIPTION

Highly effective, lightly alkaline specialized cleaner for removing exterior organic and inorganic dirt and stains. Ideal for the intensive cleaning of WPC/BPC decking and all other exterior wood-polymer composites.

### RECOMMENDED USE

Osmo Polymer Composite Cleaner was especially developed to clean WPC and BPC decking and other waterproof exterior surfaces, e.g. garden furniture and fencing made of plastic.

## INGREDIENTS

Alkaline basic cleaner: <5% cationic tensides; nonionic tensides; silicates; complexing agents; NTA and additives.

Detailed declaration of ingredients available upon request.

### TECHNICAL DATA

Specific gravity: 1.05-1.10 g/cm<sup>3</sup> Viscosity: 20-25s DIN 53211/3 mm Odour: faint/mild, after drying odourless pH value (10g/l): 10.9

## STORAGE

Up to 2 years and longer if container is kept dry, closed tightly and stored at temperatures between 5 and 35°C. Do not expose to frost during transport!

## SURFACE PREPARATION

Remove coarse dust and loose dirt from the surface with a firm broom/hand broom.

Dilute concentrate from 1:10 to 1:20 with water. A trial application is absolutely necessary!

### METHOD OF APPLICATION

Apply cleaning solution to the dirty surface, loosen dirt with a scrubber and allow solution to react for 10 minutes. Afterwards rinse thoroughly with clear water.

For mechanical processing on decking, we recommend using the Osmo Decking and Flooring Cleaning Machine.

Always use on the complete area! Do not use directly!

CLEANING OF TOOLS

Immediately after use, with soap and water.

#### COVERAGE

1 litre covers approx. 10-50 m<sup>2</sup> for one application (depending on the amount of dirt and stains).

## NOTE

Do not use undiluted. Osmo Polymer Composite Cleaner can lead to discolourations or surface changes on unfamiliar substrates. If all possible, use on the complete area. Avoid allowing the solution to dry. Not suitable for everyday cleaning and maintenance. Avoid direct contact with ornamental and farm plants.

## CAUTION
